#### MINUTES

North Dakota State Water Commission Meeting Held In Vocational Education Conference Room State Office Building Bismarck, North Dakota

May 27, 1977

The North Dakota State Water Commission held a meeting on May 27, 1977, in the Vocational Education Conference Room of the State Office Building, Bismarck, North Dakota. Governor-Chairman, Arthur A. Link, called the meeting to order at 1:40 p.m., and requested Secretary Vernon Fahy to present the agenda.

CONSIDERATION OF MINUTES OF APRIL 15, 1977 MEETING - APPROVED

Secretary Fahy briefly reviewed the minutes of the April 15, 1977 meeting held in Minot, North Dakota.

It was moved by Commissioner Gray, seconded by Commissioner Wilhelm, and carried, that the minutes of April 15, 1977 be approved as prepared and distributed.

CONTINUED DISCUSSION ON FEASIBILITY OF ADOPTING REGULATIONS LIMITING ACREAGE TO BE IRRIGATED (SWC Project No. 1400)

At the April 15, 1977 meeting, a discussion paper relative to limiting acreage for irrigation was presented to the Commission for their consideration. The paper contained the concept which would require

an absolute acreage limitation of 480 acres per landowner. Under this concept, if a landowner acquired irrigated acreage in excess of 480 acres, he must then divest himself of the water right for the excess land.

After lengthy discussion of this proposal at that meeting, the Commission directed the State Water Commission staff to prepare a draft for the Commission's consideration at its next meeting of an alternative incorporating Commissioner Just's suggestions. This proposal would limit the number of acres an applicant could apply for in any given period of time.

Murray Sagsveen, Legal Counsel for the Commission, noted that the absolute acreage limitation concept is similar to the proposal contained in the Federal Reclamation Laws, which limits a landowner to receiving water to irrigate not more than 160 acres.

Governor Link asked if the State Engineer or members of his staff have reviewed similar provisions that may be enforced in other states relative to limiting acreage for irrigation.

Secretary Fahy replied that he and several of his staff members had recently met with the Association of Western States Engineers and had discussed this topic with other state representatives. In no instances have other states made any proposals relative to the limitation of acreage, recognizing some of the problems involved. He did note that Washington State has tried to impose limiting acreage for irrigation and is now in Court as a result of it.

At this time, Governor Link invited comments from those in the audience who wished to express their views on the subject of discussion.

Marvin Werner from LaMoure, North Dakota, representing the James Valley Irrigation Association, made the following comments: this Association has recently been formed and represents approximately 180 irrigators in the southeastern part of North Dakota. Mr.

Werner related some suggestions from the Association's Board: once a landowner has applied for a water permit, his name goes to the bottom of the list of potential applicants and then when his name reappears at the top of the list, he may apply for additional acreage. The Board does not go along with the 15-20 year renewal of a permit because of the expenses involved in irrigation - receiving a permit and then when the permit is renewed, living with the possibility that maybe this permit would not be renewed. This investment would then be lost.

Recommendations presented by Mr. Werner from the Association's Board were that members of the Association meet with the State Water Commission to present input in assisting the Commission in making a determination relative to establishing a policy for acreage limitation. He also recommended that a member of the State Water Commission should be appointed from the southeastern part of North Dakota.

Allen Hansen, Ludden, North Dakota, also a member of the James Valley Irrigation Association, reiterated support of the suggestions and recommendations presented by Mr. Werner from the Board. He expressed concern of the possible 15-20 year renewal suggestion because he feels that the investment goes far beyond the costs of the irrigation system.

Frank Lassey from western McKenzie County stated that he supports the 160-acre limitation concept, because he feels that water, like energy, will have to be rationed and that more people should be able to use and benefit from this resource.

George Heinrich, Adrian, North Dakota, voiced support for the absolute acreage limitation concept, and indicated that more aquifer information, particularly the rate of aquifer recharge, should be known.

Representative Rick Maixner from New England, North Dakota, distributed and discussed progressive water rate tables relating to water use fees and acreage limitation. These tables are attached hereto and labeled as APPENDIX "A".

Representative Maixner requested to go on record as favoring the absolute limitation concept of 160 or 320 acres per operator, so that when a landowner who wants to irrigate, but doesn't have the capital today to invest in an irrigation system, will have water available for his use when conditions permit such an investment. With this concept, the same landowners will not be permitted to over-appropriate an aquifer.

Jake Swenson, a former Burleigh County Commissioner, commended the State Water Commission for the job they are doing. He noted several incidents in other states whereby irrigators have destroyed the water supply of non-irrigators and feels that the non-irrigator should receive some reimbursement when this situation occurs. He indicated that on his own land, he has several dugouts which become very low at the time of irrigation when he also needs the water.

Mr. Swenson went on record as favoring the absolute acreage limitation concept.

Ruben Hummel from Mott, North Dakota, favored the 160-acre concept per landowner, and generally discussed different aspects relative to irrigation.

Robert Sanders, representing the North Dakota Farmers Union, stated that at their convention last fall, there was considerable discussion relative to preserving the right for people who can't immediately afford to install an irrigation system, but who live over an aquifer. When finances can be arranged for the potential irrigator - will there be water available for allocation?

The delegates at the Farmers Union Convention voted to insert into the Farmers Union program, a statement requesting a limit of 160 acres per person of water allocation.

It was the recommendation of the Farmers Union Board, presented by Mr. Sanders, that the State Water Commission be encouraged to adopt a policy of a 160-acre limit per person for the allocation of water.

Governor Link asked Secretary Fahy to relate to the Commission the procedure which normally would be followed in adopting and approving rules and regulations.

Secretary Fahy replied that in most instances in matters similar to the one being discussed, the Commission would decide what they wanted to include in the proposal, a notice of hearing would be published and then a public hearing or hearings would be held.

It was the consensus of the Commission, that the procedure suggested by the State Engineer be followed as a course of action in determining a policy for the approval and adopting of acreage limitation.

APPEARANCE OF REPRESENTATIVES OF CITY OF DEVILS LAKE TO DISCUSS STORM DRAIN PLANS (SWC Project No. 1553)

Secretary Fahy recalled that sometime ago, the State Water Commission entered into an agreement with the Ramsey County Water Management District for some rural drainage in the vicinity of Devils Lake.

The State Water Commission approved participation in the amount of \$112,000 for such work.

Mr. Robert Garske, Chairman of the Ramsey County Water Management District, stated that since the engineer's estimate was completed, inflation has caused an increase in the costs of the project. Mr. James Leander, City Engineer for the City of Devils Lake, was introduced to share with the Commission members information relating to the increase.

Mr. Leander introduced the Mayor of Devils Lake, Mr. Dennis Riggin, Commissioner Lloyd G. Hinchberger, and a representative of an architectural firm, Mr. Ralph Gilbertson.

Mr. Leander distributed copies of a letter from the architectural firm. Total costs by this firm as of May 25, 1977, were \$852,228, of which 40 percent, or \$340,891 would be maximum State Water Commission participation costs, if it is assumed that all costs were qualified. At the time, the Commission approved participation of \$112,000, the engineer's estimate of the total qualified construction costs were \$280,000.

At this time, Mr. Leander requested the Commission, in light of inflation, to reconsider its participation for the increase of costs.

Secretary Fahy explained that \$112,000 was included in the 1975-77 budget and these funds are only available until July 1, 1977. He indicated that there are no funds budgeted for the Devils Lake project for the ensuing biennium. The only possible alternative for the availability of additional funds would be a cancellation of another project.

Mr. Leander stated that the call for bids is out and that the bid letting date is June 13, 1977. Awarding of the bids is expected before June 30, 1977.

It was moved by Commissioner Lanz that if additional funds are available at the end of the biennium, the State Engineer, at his discretion, should consider allocating additional funds up to 40 percent of increased qualified construction costs to the City of Devils Lake. The motion received a second from Commissioner Kramer. All members voted aye on the motion; the motion carried unanimously.

APPEARANCE OF REPRESENTATIVES FROM BURLEIGH, EMMONS, MCINTOSH AND LOGAN COUNTIES, AND REPRESENTATIVES FROM BUREAU OF RECLAMATION AND MISSOURI WEST WATER SYSTEMS COOP TO DISCUSS POTENTIAL OF RURAL WATER SYSTEMS WITHIN 12-COUNTY AREA (SWC Project No. 1574)

Mr. Daryl Fredericks, Manager of Missouri West Water Systems Coop, distributed copies of a Resolution for Domestic Water Supplies Feasibility Investigation and a Request for Authorized Funding adopted by the Missouri West Water Systems Cooperative, the Burleigh County Water Users Association, and the State Line Rural Water System. These items are attached hereto as APPENDIX "B".

Mr. Fredericks briefly explained the intent of the attached resolution.

Mr. Fredericks then introduced Mr. John Erickson, Burleigh County Water Users Association.

Mr. Erickson stated that in the fall of 1976, these Associations began initial work to request funds for a feasibility investigation for a multi-purpose water system within a 12-county area (including the counties of Dunn, Stark, Grant, Sioux, Morton, Oliver, Mercer, Burleigh, Kidder, Emmons, McIntosh and part of Logan), for the purpose of developing a Missouri River diversion water supply, central water treatment plant, trunk pipeline system and distribution network to best meet the present and anticipated future domestic water needs of at least 80,000 users living in the rural areas including cities and towns, and thereby sustain and improve the quality of life in these areas.

Mr. Erickson stated that in order to receive authorization to ask Congress for federal funds approximating \$180,000, it is necessary to receive support from the State. Therefore, Mr. Erickson requested the State Water Commission adopt a resolution expressing its support of the project. Meetings have been held with the North Dakota Congressional Delegation so they are aware of the proposal.

The feasibility study, if funds are appropriated, would be conducted by the Bureau of Reclamation.

It was moved by Commissioner Gallagher that the State Water Commission prepare and adopt an appropriate resolution expressing support of the proposal discussed. The motion received a second from Commissioner Lanz.

In discussion of the motion, Mr. Alfred Thompson, Burleigh Water Users Association, also urged the Commission's support of the proposal, and cited the critical need of good clean water in many of our rural areas.

Mr. Jim Petrik, Bureau of Reclamation, explained to the Commission members that the Bureau became involved in the study request as a result of local citizens meeting with the Bureau of Reclamation's Regional Engineer last fall requesting the Bureau to do a study. The reply the locals received from the Bureau of Reclamation was - "yes, we'll do a study, if you get it authorized".

Mr. Fay Waxner, representing the North Dakota State Association of Rural Water Systems, stated that this Board has met and discussed the proposed feasibility study, and supports such a study.

On the call of the question, all members voted aye, and the motion carried unanimously. (SEE APPENDIX "C" - Resolution No. 77-5-397, in Support of Feasibility Study for Twelve-County Rural Water System)

APPEARANCE OF BRUCE HAGEN, PUBLIC SERVICE COMMISSION, TO DISCUSS THE NEED AND FEASIBILITY FOR A REGULATION REQUIRING THE IRRIGATION OF CERTAIN RECLAIMED LANDS (SWC Project No. 1612)

Secretary Fahy introduced Mr. Bruce Hagen, Public Service Commission, who requested an audience before the State Water Commission.

Mr. Hagen expressed his compliments to the State Water Commission and its staff

for the work they are doing and in particular to the steps that are being considered in relation to possible acreage limitation for water permits. He voiced his concern that he is in favor of such limitations.

Mr. Hagen stated that on July 18, 1977 in Beulah, the Public Service Commission will be holding a three-day hearing, or longer if needed, on the gasification siting proposal of ANG. A similar hearing was held recently in Beulah on the Coyote Plant.

At the Coyote hearing, a preliminary estimate of 15,000 acres could be mined in the Beulah area over the life of the gasification plants and the question was raised to representatives attending the hearing who would like to build the plants - would you work together with a local irrigation district as you mine the land to get the coal for the plant, if such a district was formed?

Mr. Hagen indicated that one of the criteria for the Public Service Commission Siting Law is that the existing culture shall be preserved. He stated that it is not known if the soil in the Beulah area is adaptable to irrigation, but the creation of an irrigation district would enhance and intensify the agriculture of the area.

The PSC, upon completion of siting requirements, can write conditions into the permit, and suggested that perhaps one of the conditions could be a requirement that all the public utilities, the co-ops and gasification companies will have to work specifically to try to develop irrigation districts.

Mr. Hagen requested the State Water Commission staff to look at possibilities of creating an irrigation district in this area, and would appreciate any assistance which the State Water Commission could contribute.

Commissioner Gallagher recalled that when the Commission adopted conditions for conditional water permits to energy conversion applicants, a condition was adopted giving the State Water Commission the right to include additional conditions, and suggested that perhaps this may be an alternative to Mr. Hagen's proposal.

Secretary Fahy suggested that he felt this would be an excellent opportunity to involve the Universities in some fashion in doing research on the compatability of the soils.

Mr. Hagen indicated that the last session of the Legislature did authorize approximately \$480,000 for the coming biennium for reclamation-related research.

Due to the importance of the topic of discussion, Governor Link invited a motion from the Commission to adopt a resolution that would direct the State Water Commission to proceed with investigating expanding irrigation research on mined lands.

After considerable discussion, it was moved by Commissioner Gallagher that the State Water Commission staff be directed to proceed to investigate the expanded irrigation of the lands and the water requirements for irrigating lands in the coal areas; assist in the establishment of irrigation districts where feasible; and investigate the possibility of getting some large facilities to be installed to provide irrigation waters. The motion received a second from Commissioner Lanz.

On discussion of the motion, Secretary Fahy inquired if the Mined-Lands Reclamation Committee was still in existence.

Mr. Ed Englerth, PSC, replied that this Committee was still in existence.

Secretary Fahy offered a suggestion for the Commission's consideration that the State Engineer and Mr. Englerth meet with the Mined-Lands Reclamation Committee to discuss the matter and request the Committee to develop a proposal for consideration by each of the two agencies.

At this time, a substitute motion was offered by Commissioner Kramer that the State Engineer and the Public Service Commission Director meet with the Mined-Lands Reclamation Committee to develop a proposal as suggested in the original motion. Commissioner Lanz seconded the substitute motion. All members voted aye; the substitute motion carried unanimously.

CONSIDERATION OF WATER PERMIT REQUESTS (SWC Project No. 1400)

Secretary Fahy presented APPENDIX "D", representing the water permit agenda, for the Commission's consideration.

A delegation was in attendance for the consideration of water permit No. 2697, Cass Rural Water Users, Inc., who have made application for the appropriation of 500.0 acre-feet of water for municipal

(rural domestic) use from ground water. The recommendation of the State Engineer is to grant 500.0 acre-feet of water to the applicant.

Dave Ripley, Hydrologist for the State Water Commission, explained that if this request is granted, the total appropriation and pumping rate would be subject to the results of an aquifer test.

Mr. Hank Transgrud, representing Houston Engineers from Fargo and consulting engineers for the Cass Rural Water District, briefly discussed with the Commission members their immediate plans and also possible future expansion plans. He also answered general questions regarding the project.

Fay Waxner, Vice President of the Cass Rural Water Users, explained what is involved in the creation of a rural water users association. This particular rural water district being developed is divided into three phases - the request being considered today is for a water permit for Phase 2, the Leonard System. Mr. Waxner indicated that the Association will be applying for a water permit in the future for Phase 3, the Page System.

After discussion, it was moved by Commissioner Gray that the request filed by the Cass Rural Water Users, Inc., water permit No. 2697, be approved to appropriate up to 500.0 acrefeet of water for municipal (rural domestic) purposes. The motion was seconded by Commissioner Wilhelm. All members voted aye, the motion carried.

Considerable discussion then centered around acreage limitation, aquifer management, predictive modeling of aquifers and county ground-water studies.

It was moved by Commissioner Gray that the balance of the water permits which have been recommended for approval by the State Engineer be granted, subject to the conditions indicated on each respective permit. The motion was seconded by Commissioner Gallagher. All members voted aye; the motion carried unanimously.

APPEARANCE OF DALE FRINK TO PRESENT STATUS REPORT ON YELLOWSTONE LEVEL "B" STUDY (SWC Project No. 1508) Due to a previous commitment making it necessary for the Assistant Study Director of the Yellowstone Level "B" Study, Don Ohnstad, to be in Omaha this date, Dale Frink, a State Water

Commission staff member and a member of the State Study Team of the Yellowstone Study, presented an updated report of the study to the Commission members.

Mr. Frink indicated that the State Study Team is probably one of the most important aspects of the study because this is the team that has to come up with a recommended plan. The State Study Team consists of State and Federal agencies and various citizens.

The Study Team met in April and considerable progress toward the recommended plan was made at that meeting. It is hopeful that the recommended plan can be completed at the Team's meeting on June 1 and 2.

He discussed some of the projects and actions that the State Study Team has recommended: 1) four rivers in the State of North Dakota be designated as scenic rivers (a) the Yellowstone River from Montana State line to confluence of the Missouri River; (b) the Knife River from Manning to the Missouri River; (c) the Heart River below Heart Butte Dam; and (d) the Cannonball River east of Shields; 2) the team has recommended that the level of energy in this area be restricted to what has already been granted by the State Water Commission; 3) irrigation in the 15-county area be limited to private development; and 4) accelerate funding for programs that require environmental-based data.

Mr. Frink reviewed the time schedule for completion of the project indicating that North Dakota's draft is scheduled for completion June 30, 1977, and Montana and Wyoming's drafts are due for completion approximately three months later. After all three states have completed their drafts, there is a 45-day review session in which the Missouri River Basin Commission must act, and then there is a 90-day formal review period. The final date of completion is when the plan is submitted to the Water Resources Council, tentatively scheduled for February, 1978.

CONSIDERATION OF ADOPTION OF RESOLUTION REQUESTING CORPS OF ENGINEERS TO CONDUCT STUDIES TO DETERMINE FEASIBILITY TO SNAG AND CLEAR RED RIVER OF THE NORTH (SWC Project No. 1638)

Secretary Fahy presented a draft resolution for the Commission's consideration which would request the Corps of Engineers to conduct studies to determine the feasibility of snagging and clearing the Red River of the North as it borders on Cass

County, North Dakota, under the authority provided by Section 208 of the 1954 Flood Control Act as amended.

He noted that if it is found feasible and advisebase to snag and clear the Red River of the North as it borders on Cass County, North Dakota, the State Water Commission would be required before construction commences to enter into a contractual agreement that it will provide such local cooperation as may be prescribed by the Secretary of the Army.

It was recommended by the State Engineer that the Commission adopt such a Resolution.

It was moved by Commissioner Lanz, seconded by Commissioner Kramer, and carried, that the State Water Commission adopt Resolution No. 77-5-396, Snagging and Clearing Red River of the North, and transmit appropriate number of copies to the Corps of Engineers requesting them to conduct studies to determine the feasibility of snagging and clearing the Red River of the North as it borders on Cass County, North Dakota. (SEE APPENDIX "E")

### RESOLUTION FOR DOMESTIC WATER SUPPLIES FEASIBILITY INVESTIGATION APPENDIX "B"

WHEREAS, most of North Dakota is agriculturally based and primarily rural in nature composed of many small cities and communities, and;

WHEREAS, much of the settled area is semi-arid where ground water supplies are absent, limited; or of extremely poor chemical quality, and;

WHEREAS, the quality of rural living for thousands of families remains unfulfilled so long as these areas lack satisfactory domestic water supplies, and;

WHEREAS, Public Law 93-523 (The Safe Drinking Water Act) stipulates water quality parameters which are of higher quality than area ground water produces, and;

WHEREAS, the Missouri River traverses the State of North Dakota with substantial streamflow and has considerable storage regulation already in operation, the water quality of which meets both Federal and State water quality criteria and thereby could become a permanent and adequate domestic water supply source for much of North Dakota, and;

WHEREAS, the Counties of Morton, Oliver, Mercer, Sioux (north portion including Standing Rock Indian Reservation), Grant, Stark (east portion including the City of Dickinson), Dunn, Burleigh, Kidder, Emmons, Logan (west portion) and McIntosh (west portion) including all cities, towns, farms, ranches and rural residents living therein are in urgent need of an adequate, multi-purpose quality water supply, be it

RESOLVED that the Bureau of Reclamation of the Department of the Interior, be authorized to undertake a feasibility investigation for a multi-purpose water system within this 12-county area, for the purpose of developing a Missouri River diversion water supply, central water treatment plant, trunk pipeline system and distribution network to best meet the present and anticipated future domestic water needs of at least 80,000 users living in the rural areas including cities and towns, and thereby sustain and improve the quality of life in these areas.

#### REQUEST FOR AUTHORIZED FUNDING

The human hardships and hazards to health imposed by inadequate domestic water supplies require efforts toward solution of the problems commensurate to the conditions experienced.

The efforts of the undersigned over several years have failed to provide an economically affordable solution to the water related problems in this area.

Many families must out of necessity haul water for household use because of poor water quality found in underground sources. Livestock operations which are an important component in the agricultural economy of this area are often curtailed or eliminated by circumstance of inadequate water supplies. Periods of low rainfall affect water tables of range wells and stock dams dry out leaving the herdsman without sufficient water sources for his animals.

Necessary fire protection services in rural areas are often inadequate because of the lack of sufficient and available water sources.

The geographical area described also encompasses the urgent needs experienced by the major growth areas in North Dakota due to energy development and concomitant population increases. Cities including Bismarck, Mandan and Dickinson are no longer able to cope with the rapid expansion of services needed to accommodate the growth.

The domestic water supplies feasibility investigation will require an authorized amount of \$180,000 to provide for an 18-month feasibility investigation on this 12-county area under the direction of the Bureau of Reclamation of the Department of the Interior working in concert with the communities and rural citizens living in this area.

The undersigned respectfully request the assistance of the North Dakota Congressional Delegation in facilitating the authorization needed and their wholehearted support in obtaining the funds needed to initiate this program forthwith.



#### In Support of Feasibility Study for Twelve-County Rural Water System

WHEREAS, all cities, towns, farms, ranches and rural residents living within the tweleve-county area are in urgent need of an adequate, multi-purpose quality water supply; and

WHEREAS, the feasibility investigation will study the development of a Missouri River diversion water supply, central water treatment plant, truck pipeline system and distribution network which would best meet the present and anticipated future domestic water needs of at least 80,000 users living in the rural areas of the twelve-county area; and

WHEREAS, if implemented, the proposed rural water system will thereby sustain and improve the quality of life in these areas; and

WHEREAS, the domestic water supplies feasibility investigation will require an authorized amount of \$180,000.

NOW, THEREFORE, BE IT RESOLVED, by the North Dakota State Water Commission at its meeting held in Bismarck, North Dakota, on May 27, 1977, that it fully endorses and supports legislation authorizing the Bureau of Reclamation to conduct, in concert with the communities and rural citizens living within the designated area, a feasibility investigation of the proposed rural water system.

#### RESOLUTION 77-5-396

Snagging and Clearing Red River of the North

BE IT RESOLVED by the North Dakota State Water Commission at its meeting held on May 27, 1977, in Bismarck, North Dakota, that it hereby requests the U. S. Army Corps of Engineers to conduct studies to determine the feasibility of snagging and clearing the Red River of the North as it borders on Cass County, North Dakota under the authority provided by Section 208 of the 1954 Flood Control Act as amended.

It is understood that if it is found feasible and adviseable to snag and clear the Red River of the North as it borders on Cass County, North Dakota, the North Dakota State Water Commission would be required before construction commences to enter into a contractual agreement that it will provide such local cooperation as may be prescribed by the Secretary of Army.

The State Engineer and Secretary of the North Dakota State Water Commission shall be and is hereby directed to transmit three certified copies of this resolution to the District Engineer, St. Paul District, U. S. Army Corps of Engineers, 1210 U. S. Post Office and Custom House, St. Paul, Minnesota 55101.
